## Taxation

A carbon tax is a tax levied on the carbon content of fuels (transport and energy sector) and, like carbon emissions trading, is a form of carbon pricing. The term carbon tax is also used to refer to a carbon dioxide equivalent tax, the latter of which is quite similar but can be placed on any type of greenhouse gas or combination of greenhouse gases, emitted by any economic sector.
