6.4.3.2. Forecasting with Single Exponential Smoothing

The average age of the data in the simple-exponential-smoothing forecast is $1/\alpha$ relative to the period for which the forecast is computed. (This is not supposed to be obvious, but it can easily be shown by evaluating an infinite series.) Hence, the simple moving average forecast tends to lag behind turning points by about $1/$
